Important meeting announcement for the Unit...

Hello Wisconsin Unit Member!

One of my first tasks as your new President, is to update our (Unit's) Constitution and Bylaws. This is required by the Wally Byam Caravan Club International (WBCCI) every five years, and must be completed by the end of 2018 since our last review and update was in 2013. I need your help to complete this important task, so please read all the way to the bottom.

WBCCI provides a (process) for each Unit to follow (in reviewing) the Constitution and Bylaws. Our Unit Executive Board (has) met to discuss the 2018 WBCCI Constitution model, compare it to our previous Constitution (2013), and to meld the two into a proposal. This proposal is (included in this newsletter).

The two biggest differences between our proposal and what WBCCI suggests in their model are :

1. (Unit Constitution reads:) We have three trustees as part of our officers and those trustees serve three year terms with one trustee replaced each year.
(WBCCI Constitution Model suggests:) Two trustees and two year terms, with one trustee replaced each year.
2. (Unit Constitution reads:) We have two business meetings scheduled each year, one in the spring and one in the fall.
(WBCCI Constitution Model suggests:) one scheduled business meeting per year.

Our Constitution requires a vote by the membership to adopt any revision.

So you can vote 2 ways: (a) by attending the November 3 Luncheon in Sturgeon Bay or (b) by sending me an email (jcooper@new.rr.com) indicating your vote. I can accept your vote through the end of October.
